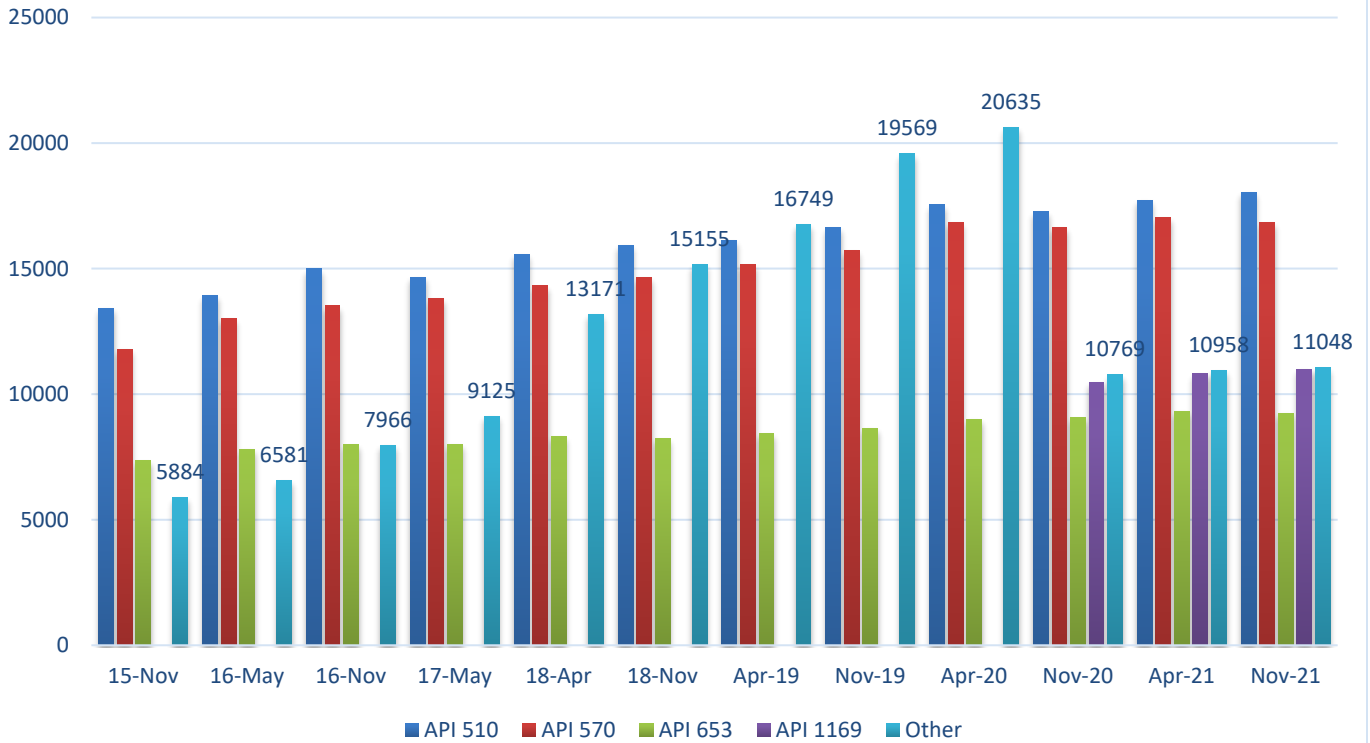

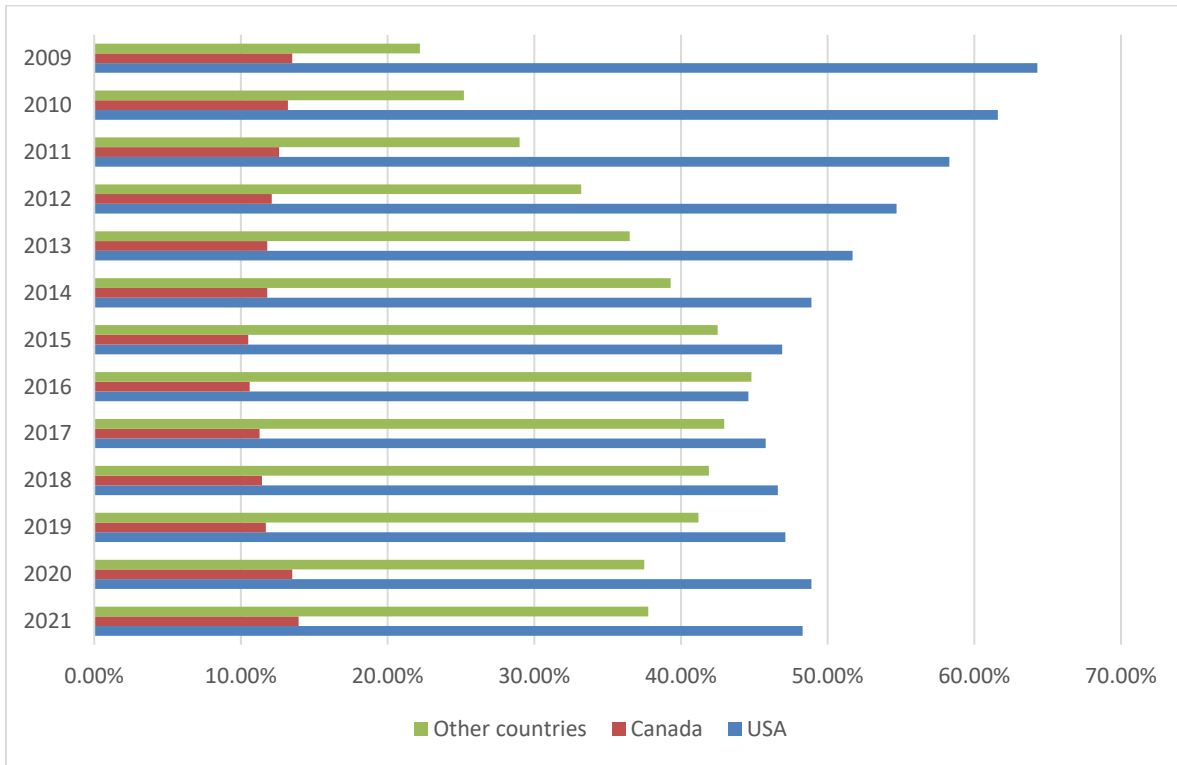

Global Certificate Distribution (Total by Country)

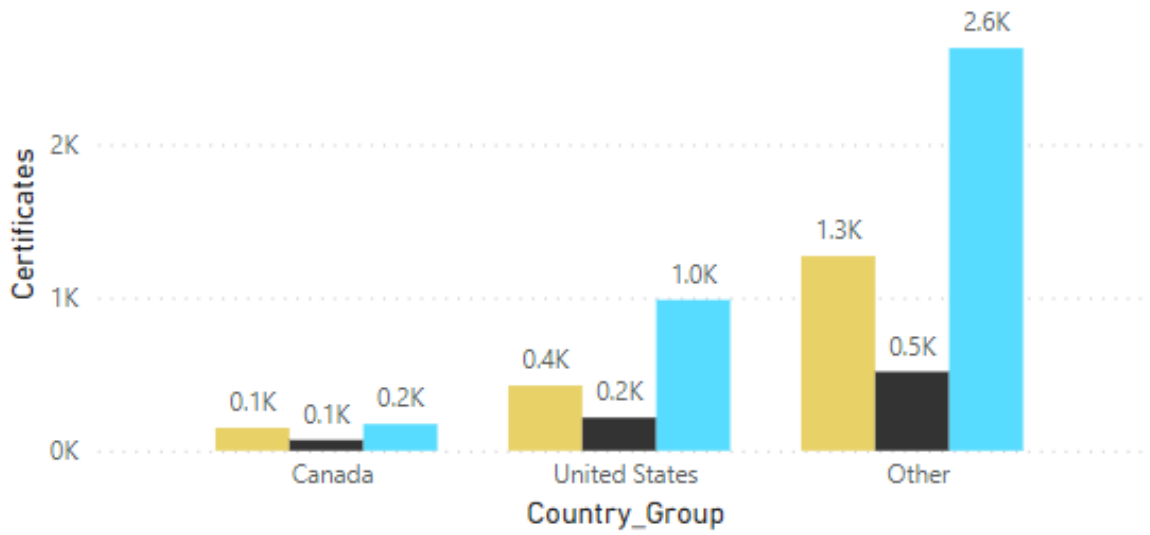

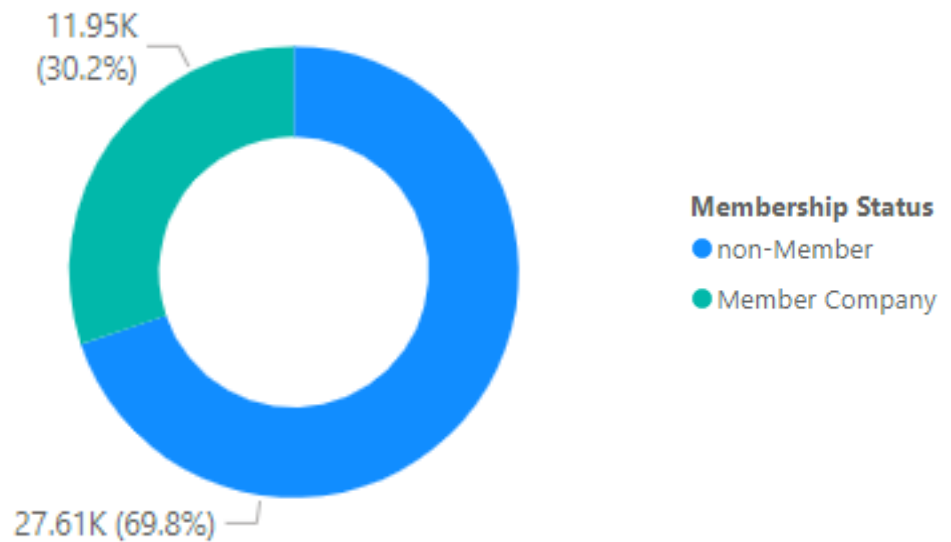
Breakdown of Specialized Programs

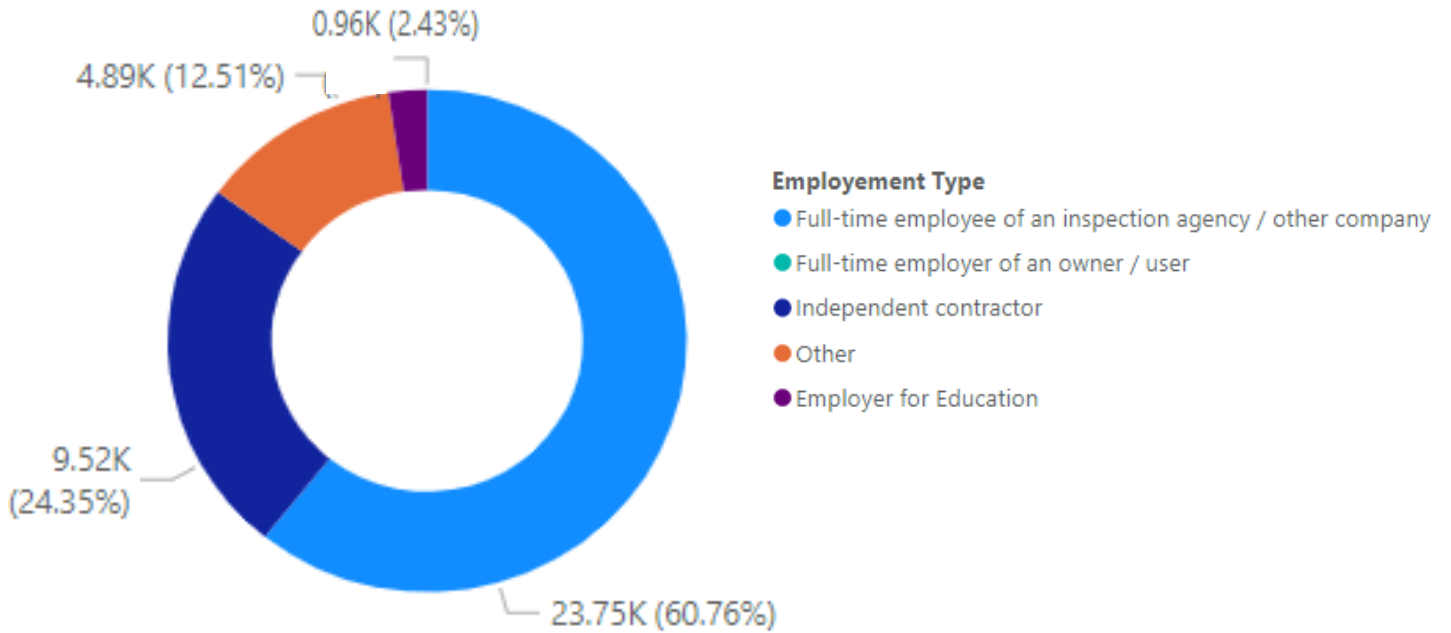

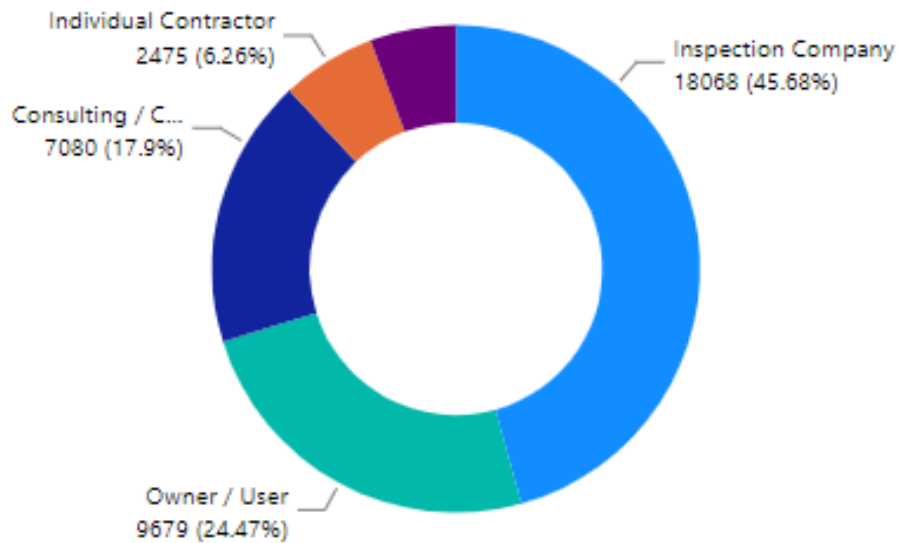


Demographic Breakdown of Certified Inspectors

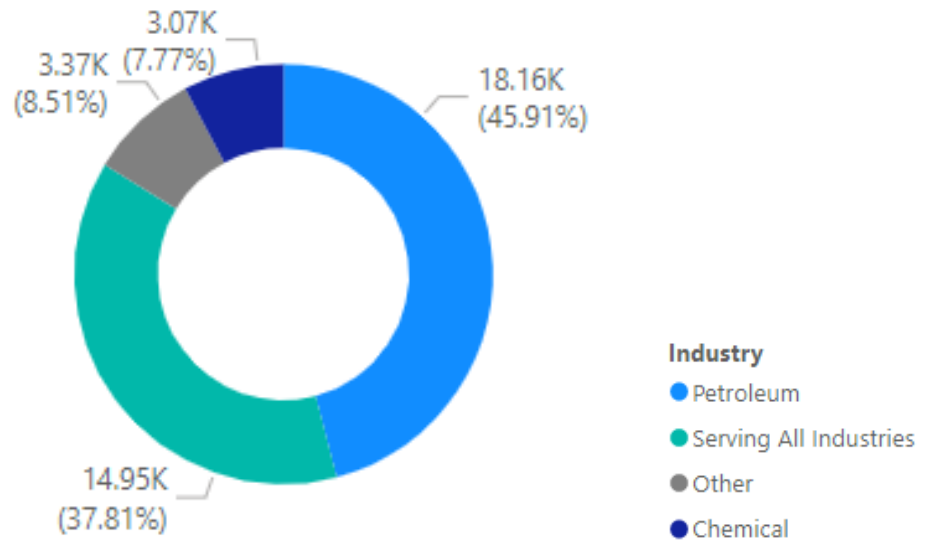
Active Certified Inspectors by Employment Type



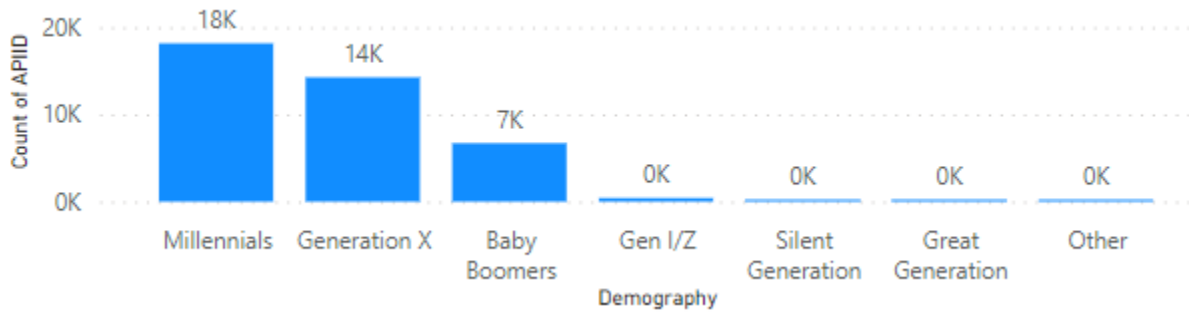
Active Certified Inspectors by Organization Type



Active Certified Inspectors by Industry Type

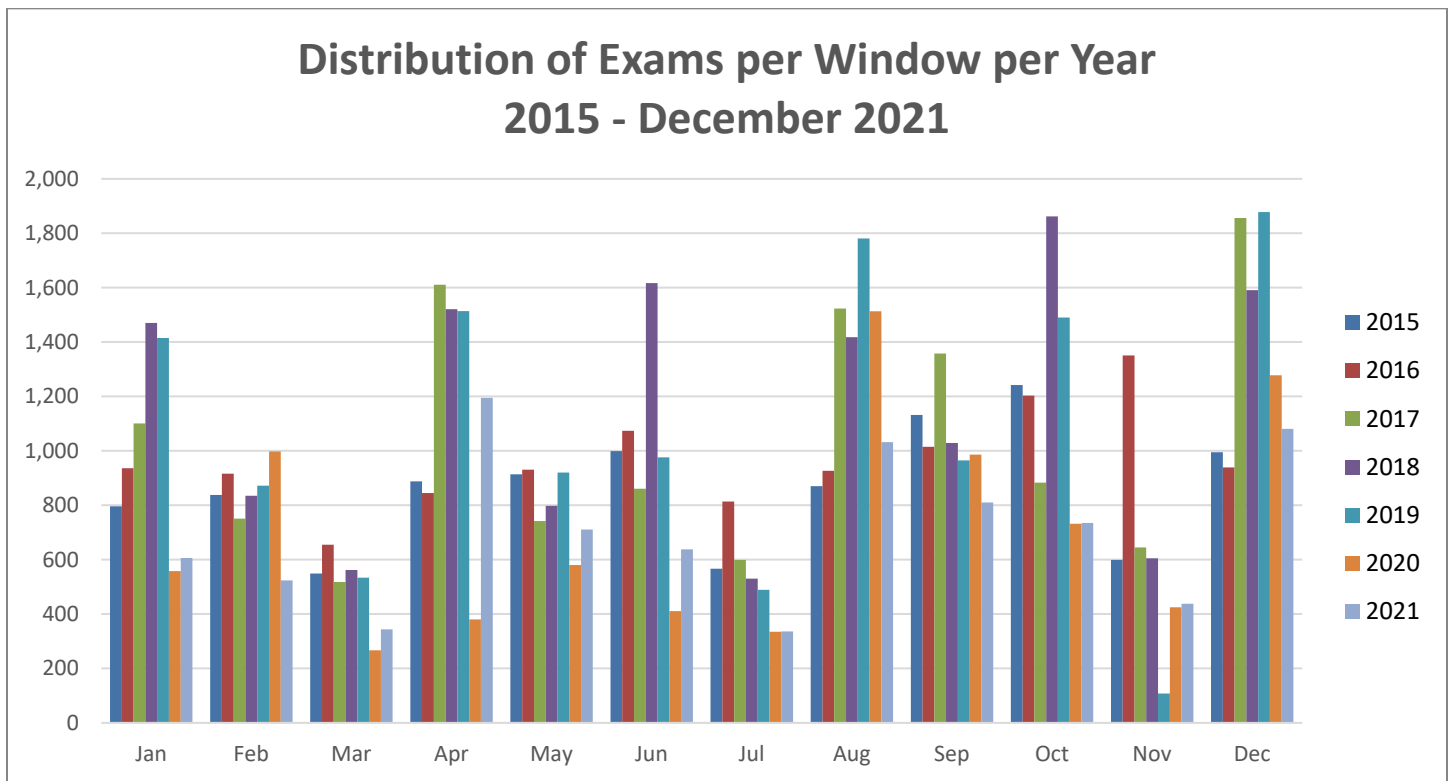


Active Certified Inspectors by Age Group

Breakdown of Exams Administered



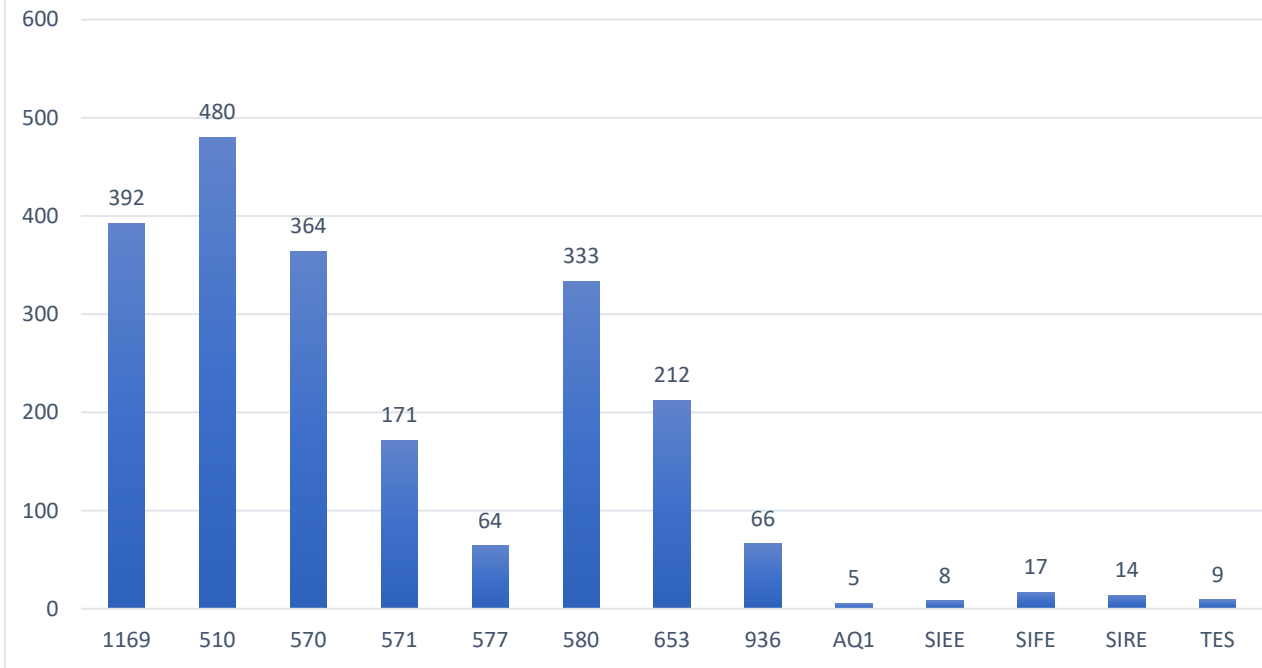

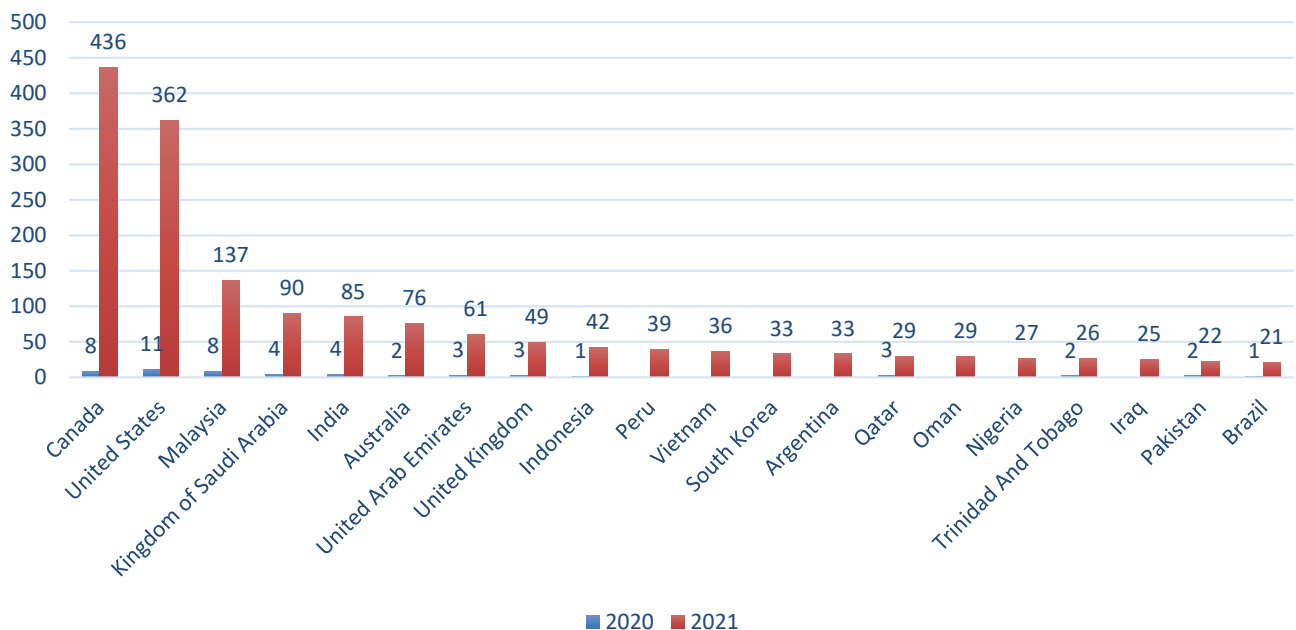
*COVID-19 impact to testing began in earnest March through May 2020. During that period, we had over 2,000 displaced testers rescheduled to later dates that are reflected in the August and September 2020 windows. We start to see exam scheduling pick up again in early 2021, with spillover from those rescheduling from 2020 exams. 2021 exams are only being reported against current scheduling through December 2021.

Remote Exams 2020 - 2021

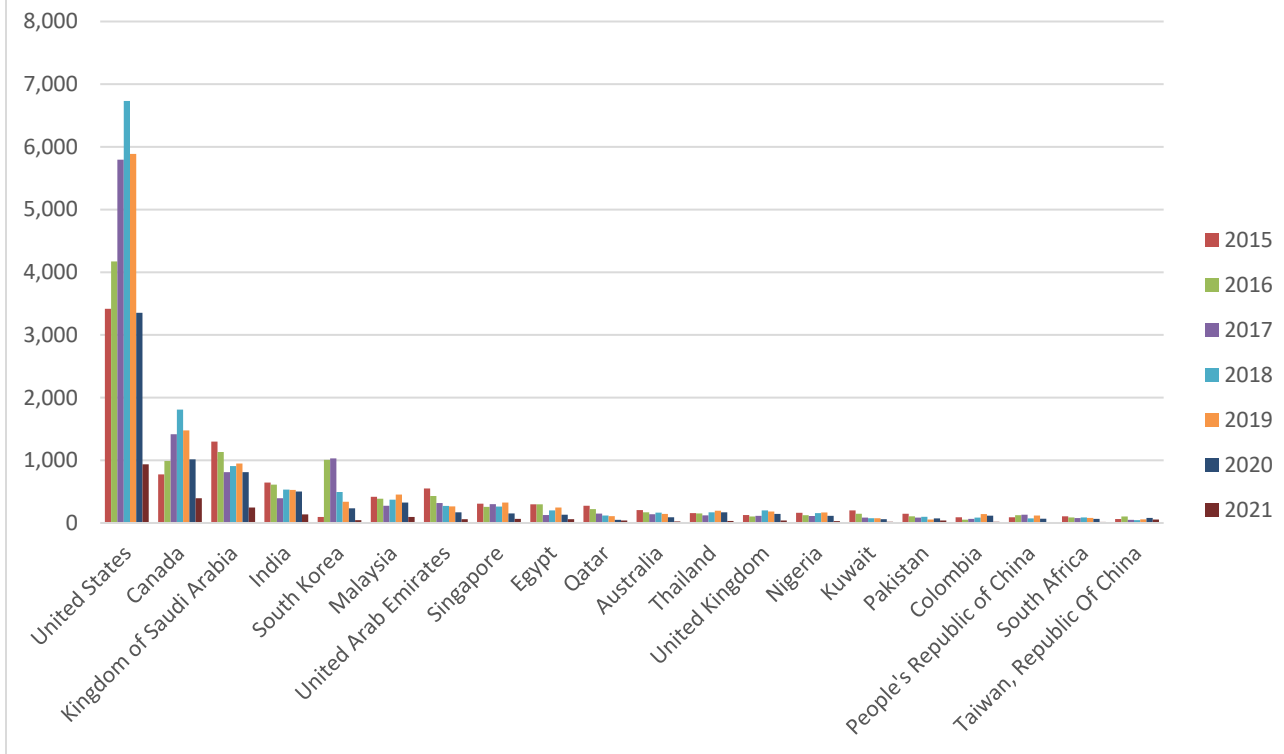


Remote exams were piloted starting with the smaller CBT exams in November 2020. They were then expanded across all programs starting with the February 2021 570 window. This modality will continue to be offered, and will be monitored as we move forward.

Between 2015 and year end 2021, ICP will have administered 97,246 exams in 141 different countries. Of these, 3,460 are a combination of paper and performance-based, with the remaining 78,145 computer-based (CBT). We will have utilized approximately 438 of the over 500 Prometric testing centers around the world.

Above the chart shows the top 20 countries over the last 5 years. As you can see, over time, 88,554 (91%) of our exams were delivered in those top 20 countries. The country breakdown can be seen in the table to the left.
