

Certified Inspectors Worldwide



Global Certificate Distribution (Total by Country)










Demographic Breakdown of Certified Inspectors


Active Certified Inspectors by EmploymentType




Active Certified Inspectors by Oraganization Type



Active Certified Inspectors by Industry Type




Breakdown of Exams Administered





The remote exams have seen increased interest overtime. While it is not expected that this modality will overtake the inperson centers, we have administered over 7,700 remote exams since 2020. In 2023 we administered over 1,900 remote exams. For 2024, as of October we have 1,824 remote exams scheduled for the year. Going forward remote exams will be available for the specialized and smaller exams.

Between 2015 and October 2024, ICP has administered 112,302 exams in 132 different countries. Of these, 104,727 are computer-based (CBT) and the remaining 3,959 are a combination of paper and performance-based. We will have utilized approximately 435 of the over 600 Prometric testing centers around the world.

Above the chart shows the top 20 countries over the last 6 years. We delivered roughly 75,448 exams. Over that time 68,893 (91%) of our exams were delivered in those top 20 countries. The country breakdown can be seen in the table to the left.
